Enforce City and State labor protections for ride-hail and delivery workers

- Ensure workers are compensated at SF's minimum wage
- Ensure health care ordinance contributions and paid sick leave
- Prioritize enforcement of Assembly Bill 5



Require licenses for meal and food delivery workers


- Licenses could be capped in order to improve earnings
- Caps could also help reduce traffic and congestion

The license system should not place financial burdens on workers, or create extensive red tape, and should be developer in rigorous consultation with workers.



The City should explore creating a Ride-hail and Delivery Worker Resource Center

Center could educate workers on their rights and provide resources to resolve complaints with the ondemand companies



Ride-hail and delivery workers often find themselves

fired or "deactivated."





The City should create a task force to explore the viability of a City-Run worker-owned ride-hail and delivery cooperative

- Clear these services are valued by San Franciscans
- Companies argue they cannot afford to comply with Assembly Bill 5
- Company models are not sustainable



Improve access to company data

The City should pursue a multitiered, multi-agency strategy for securing validated, ongoing data needed for setting, implementing and enforcing policy




Driver collected data can be analyzed to provide meaningful input to policy makers.



The City needs robust, continuous, verified data for design, implementation and enforcement

- Driver/delivery workers wages and hours.
- Driver/delivery worker eligibility for employment related benefits & protections.
- Driver/delivery worker contact and demographic information.
- On-Demand mobility or delivery worker platform contribution to regional and local vehicle miles traveled, traffic congestion or greenhouse gas emissions.
- Impact of delivery platforms on small businesses.





The City should compel agencies like SFPD to develop privacy-forward methods to collect and share information about collisions and injuries involving on-demand ridehail and delivery workers

- Information would benefit public health
- Help the City achieve its Vision Zero goals of zero traffic deaths
- Data could be combined with labor data to demonstrate labor practices industry wide



Document the fiscal and social impact of worker misclassification by ride-hail and delivery apps

Direct the Budget and Legislative Analyst to generate a report on the financial and social impacts of the on-demand industry's worker misclassification. The report would estimate:

- Costs to the City's public health infrastructure from non-payment of mandated employer contributions to health care and workers' compensation insurance.
- The tax liability arising from misclassification.
- The total amount of unpaid benefits that workers are entitled to under the retroactive enforcement of AB 5.
- The social impacts of this longstanding practice of non-payment of mandated worker benefits.

Provide free and accessible restrooms to workers

The Department of Public Workers should explore the creation of a public facility for app-based delivery and ridehail workers that provides them with free restrooms. The facility should be parking-accessible.





Address safety hazards for bicycle delivery

- Rapid buildout of protected bikeways, especially on high-injury corridors and busy streets
- Dramatically expand loading zones on busy commercial corridors
- Expand and make permanent a Slow Streets network



Establish an e-bike rebate program

Program should be funded by companies in collaboration with bike manufacturers of Uber and Lyft drivers would shift or maybe shift to an e-bike for delivery if they were offered an incentive

of delivery drivers said yes they would switch to e-bike with an incentive


